- 1. Every bidder shall submit only one quotation.
- The price for goods supplied shall include all custom and excise duties and sale and other taxes already paid or payable on the raw material and components as well as on sale of goods. Department will not make any payment in respective of any type of tax or any levies.
- 3. The rates mentioned in the quotation shall include all the expenditure regarding transportation, loading, unloading etc. department will not pay any extra payment except the rates mentioned in the quotation for the supply of desired stores/ material.
- 4. Bidder shall be required to submit quotation (rates) valid for a period of 40 days.
- 5. Quotation may be submitted in sealed envelope up to 1.00 PM on Dated 26.12.2019 and quotation will be opened at 3.00 PM on Dated 26.12.2019.

- 8. The delivery period shall be 30 days after the date of dispatch of purchase order. The delivery period shall not be extended in normal case but it may be extended on producing valid reasons by the bidder in writing to this office.

9. Liquidated Damages

9.1. In case of extension in the delivery period with liquidated damages the recovery shall be made on the basis of following percentages of value of stores which the bidder has failed to supply:
