



5. Bidder shall deposit Bid security declaration for an amount of 2% of estimated cost of the work.
6. The Technical Bids shall be opened at 03.00 PM on dated 15.07.2021 in the office of the Procurement Officer, SPMU, Atal Bhujal Yojana, GWD, Jaipur by Procurement Officer in the presence of the Bidders or their representatives who wish to be present.
7. The procuring Entity is not bound to accept the lowest Bid and may reject any or all Bids without assigning any reason thereof.
8. The Bidders shall have to submit copy of a valid GST Registration from the concerned Commercial Taxes Officer and the Permanent Account Number (PAN) issued by Income Tax Department.
