

Business Reforms Action Plan 2017 for Ease of Doing Business (EoDB) requires processing of only online applications for new water connection to Enterprises (commercial/institutional/industrial) through Single Window Clearance System portal. Accordingly, it is enjoined upon all officers to mandatorily process only online applications for new water connection to Enterprises only through single window portal i.e. www.swcs.rajasthan.gov.in within the time frame given in the circular dated 24.08.2016. Physical submission of application for new water connection to Entrepreneur shall not be accepted and processed.
