

In partial modification to the Notification issued vide FA&CAO/RWSSMB/Mission/2014-15/245-262 dated 05.11.2015, under the powers conferred to the Rajasthan Water Supply & Sewerage Management Board (RWSSMB) vide Government Order dated 28<sup>th</sup> April 1980, the Governor is pleased to order that **water tariff applicable** upon small shops and offices e.g. **Grocery Shops, Doctor's Clinics and Advocate's Consultation Chambers etc. measuring built-up** area up to 200 sqft., with bonafide use of water in only drinking and sanitary purposes is to be converted from Non Domestic Water Tariff to Domestic Water Tariff. All other Commercial establishments e.g. **Beauty Parlours, Washing Units, Dhabas, Restaurants/Tea Stalls etc.** with non drinking/sanitary uses of water or **shops and offices including other Commercial establishments with built-up** area more than 200 sqft., will continue to be charged under Non Domestic Water Tariff.

This shall come into effect from May'2016 for bills payable in the month of June, 2016.
