

**Guidelines for Enlistment of Vendors/ Manufacturers of various types of Pumps as per Evaluation Criteria based on Marking Pattern**

1. Vendors who are manufacturer of various types of Pumps have to download and fill the Enlistment form and enclose documents as per "List of enclosure", already available on departmental website".
2. Check list of marking pattern for enlistment of vendors of various type of **Centrifugal Pumps (Other than Submerged Centrifugal Pump)** mentioned as **Category 1** to be used in water supply schemes/ projects of PHED, Rajasthan along with **Annexure A(Mandatory Criteria)** , **Annexure B** and **Annexure C** is now available on departmental website as "**Form M-3**".
3. Check list of marking pattern for enlistment of vendors of **Submerged Centrifugal Pump Set (Wet Installed, Single Stage Volute Type, with Motor Mounted on extended impeller shaft without coupling)**, to be used in water supply schemes/ projects of PHED, Rajasthan along with **Annexure A1 (Mandatory Criteria)** , **B1**, **C1**, is now available on departmental website as "**Form M-4**".
4. Vendors / manufacturer of various types of pumps have to download Form ~~M-2~~ <sup>M-3</sup> or/ and Form ~~M-3~~ <sup>M-4</sup> as applicable to them. Vendors have to check and submit the additional documents (in addition to documents enclosed at para 1 above), required as per Annex. A (Mandatory Criteria), B & C of **Form M-3** and Annex. A1 (Mandatory Criteria) , B1 & C1 of **Form M-4** as applicable.
5. Documents required as per Form M-3 & Form M-4 will be preferred over documents as per "List of enclosure" in case of any dispute/ ambiguity.
6. During scrutiny, mandatory criteria i.e Annexure A/A1 will be checked first, both in case of Form M-3 or/and Form M-4.
  - a) The applicant full filling all the mandatory criteria (applicable), shall only be eligible & considered for further evaluation. The documents submitted as per Annex. 'B' or/and 'B1" (Form M-3 or/and Form M-4 respectively), will be examined and marks will be allotted accordingly.
  - b) If applicant is eligible w.r.t. mandatory criteria (Annexure A/A1) and visit to manufacturing unit will be decided then Annex. 'C' or/and 'C1' (Form M-3 or/and Form M-4 respectively) will be applicable.
  - c) Marking of Part A and Part B of Annex. 'C' or/and 'C1' (Form M-3 or/and Form M-4 respectively) will be on the basis of document submitted & subsequently verified during shop survey.





- d) Marking of Part C of Annex. 'C' or / and 'C1' (Form M-3 or/and Form M-4 respectively) will be as witnessed, during shop survey.
- e) In case, applicant does not full fill any of the mandatory criteria (applicable), then the applicant shall not be considered for further evaluation and informed accordingly.
7. Minimum qualifying marks will be 75%. The vendor securing marks 75% or more in evaluation as per annexure "B"/ "B-1" or "C"/ "C-1" as the case may be, will be considered as recommended for approval for that type of Pump
8. Separate sheet will be prepared for each type of Pump.
9. Technical Committee of the department will be the final approving authority.
10. After approval of Technical Committee the Name of vendor / Make of vendor will be added to "List of Specified Makes" of the department and vendor will be informed accordingly.

**NOTE:** Evaluation of new submission for enlistment of vendors for various types of Pumps is now being done on the basis of marking pattern as approved by TC/ 713 dated 17.12.2021. Already approved vendors of Pumps, as per "List of Specified Makes" updated up to 31.08.2021 will also be reviewed periodically and subsequently based on the new evaluation criteria (i.e. marking pattern).
