Subject: - Inspection of External and Internal water supply installation of Industrial Water Connections.

Rajasthan Water Supply Rules 1967 Clause No. 13 (ii) provides inspection by technical representative of the Department of installation and extension of pipeline beyond meter and inside the premises carried out by a licensed plumber or approved contractor as and when desired and directed by the Department. As per directives of Reform points pertaining to sub area- Obtaining water connection under Business Reform Action Plan 2024 (BRAP-2024) for Ease of Doing Business in the State it is required to mandate frequency of inspection of external and internal water supply installation works by a licensed professional or company for checking quality, safety etc. of the installation works and also the quality check and inspection by the third party to ensure quality and safety of water supply installations.

In pursuance to above Rules and directives of BRAP-2024 following is directed:-

"The external and internal water supply installation works of water supply industrial connection shall be inspected by a licensed plumber or approved contractor once in every **Five Years** for quality and safety checks and submit report in this regard to concerned Assistant Engineer/Junior Engineer. The concern Assistant Engineer/Junior Engineer shall finally inspect the internal/external installation works for quality and safety of the industrial connections under their ambit and shall issue certificate of final inspection in the Form-I enclosed. Record of such inspection shall be kept in sub division for reference and a copy of same be provided to the respective consumer also."

This Order shall come into force with immediate effect.
